DOGS ELIGIBLE TO ENTER

This event is open to all dogs four (4) months of age or older that are registered with the American Kennel Club or approved Foundation Stock Service (FSS) breeds are eligible to participate. No Champions of Record may compete in an Open Show. Professional handlers or agents are only permitted to exhibit in FSS Open Shows if they are listed as an owner of record of the dog being exhibited. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

Dogs should be physically sound. No dog shall be judged if it is taped, bandaged, glued or has stitches anywhere including ears or tail in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the event grounds.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
